ENTRY FEE: \$150 per team-unlimited number of runners per team, \$20 per individual runner

NOTE: Boys and girls are considered separate entry fees. Maximum entry fee is \$150 for boys and \$150 for girls.

AWARDS: Long sleeve tee shirts to the top 12 finishers in each Varsity race. Medals to the top 50 finishers in each Varsity race, medals to the top 20 finishers in all other races. Ribbons to all other finishers. Team plaques to the top five teams in each Varsity race, first place plaques in JV & Frosh.

GENERAL INFORMATION:

1. JV runners will run the same 5K course as Varsity runners.
2. Frosh will run a 1.5 mile course over the bridge.
3. The nearest hotels are the Radisson Hotel in Hauppauge and Hampton Inn LI in Commack. These hotels are approximately 10 minutes from the park.
4. Long sleeve custom tee shirts and sling back-packs will be on sale.
5. Team must first be entered in varsity race before entering JV.
6. Toll at Sunken Meadow State Park bus entry fee is \$35 with state permit, and \$75 without state permit.
